RE: 105TH WALES COVID-19 UPDATE

Dear Residents, Employees, Family Members, and Volunteers,

I am saddened to inform you that we now have three COVID-19-positive residents: two RPA residents living on Shaw 1 and one CHSLD resident living on Norton 3. The three residents are under closed-door isolation. The regulations for visiting COVID-19-positive residents are:

- A maximum of four primary caregivers must be identified for the resident
- Only one primary caregiver is authorized to visit per day
- This person can visit multiple times in the same day
- Prior to visiting, please contact the unit to ensure you know the isolation protocols

We have put Norton 3 on *preventive* isolation, as there was a group activity on the unit this morning. Although Public Health considers the RPA in an outbreak, Manning 1 is not on preventive isolation, as our residents are fully vaccinated. Since Tuesday, March 29th, 2022, we have had seven additional employees test positive for COVID-19. Below are the vaccination results from yesterday's fourth dose campaign:

- **CHSLD:**
 - **Norton 1 and Norton 3:**
 - Each resident received their fourth dose
 - **Norton 2:**
 - Twenty-six residents received their fourth dose
 - Two residents received their third dose
 - One resident refused; they have their third dose
 - Two residents were not eligible for their fourth dose, as they had their third dose less than three months ago
- **RPA:**
 - **Central:**
 - Seven residents received their fourth dose
 - One resident received their third dose
 - Two residents refused; both had COVID-19 in December, one has three doses and the other has two
 - Two residents will be eligible for their fourth dose on Tuesday, June 9th, 2022
 - **Shaw Sub-Basement, Manning Basement, Shaw 3, and Shaw 4:**



- Each resident received their fourth dose except one who was hospitalized at the time
- **Manning and Shaw 1:**
 - Twenty residents received their fourth dose
 - One resident was not eligible as they were COVID-19-positive at the time
 - One resident was not immunized as they were on vacation with their family at the time
- **Manning and Shaw 2:**
 - Twenty-five residents received their fourth dose
 - Two residents received their third dose

Thank you for your understanding and cooperation with sanitary measures. I appreciate your efforts to help us protect our residents and employees from this deadly virus.
