RE: FIFTY-FIRST WALES COVID-19 UPDATE

Dear Family Members,

Yesterday, we were informed by the Minister of Health (MSSS), Mr. Christian Dubé, of new decree 2021-032, which stipulates that employees working in a private CHSLD (*privé non-conventionné*) have an obligation to provide their employer with proof that they have received one dose of a COVID-19 vaccine *or* supply evidence that they tested negative for COVID-19 *three* times per week.

The CHSLD Wales Inc. will allow a grace period until June 1st, 2021 to apply the above decree. Below is the vaccination rate data we sent to the MSSS:

CHSLD Wales Inc. residents are scheduled to receive their second COVID-19 vaccine dose on Wednesday, May 5th, 2021. The CIUSSS will be onsite at 10:50 a.m. to process vaccinations.

We were informed today that Résidence Wales Home residents will receive their second dose of Pfizer on May 20th, 2021. Please see the decisional tree on the following page for instructions on vaccinations for those who have tested positive for COVID-19.

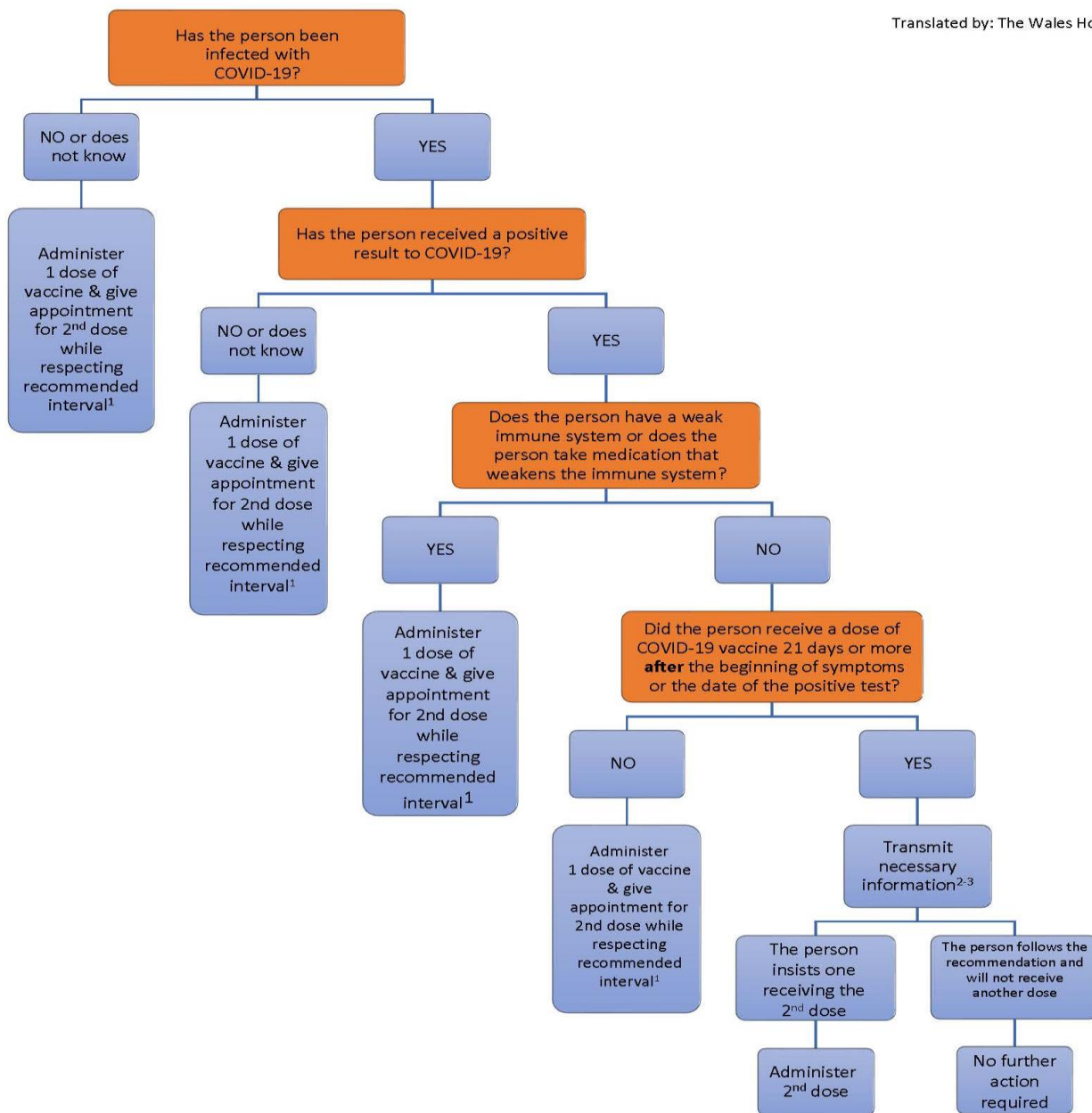

1. To learn more about recommended interval, consult [PIQ](#).
2. If the person has had COVID-19 in the past three months, they can make another vaccine appointment respecting the 3-month interval as recommended, or receive their vaccine today.
3. It is not dangerous to administer 2 doses of vaccine to this person. The risk of undesirable side effects is greater and the 2nd dose will not offer them increased protection.
