Since Sunday, April 3rd, 2022, thirty-four employees have been out sick with the virus. As of Saturday, April 16th, 2022, eighteen have returned for a total of fifty-three percent.

After publication of yesterday's COVID-19 update, another employee tested positive, and four more residents did so today. Today, we received notification from Public Health that a Norton 2 resident who was tested on Friday, April 15th, 2022 was negative, however said resident was symptomatic this morning and tested positive on a rapid test.
