After publication of our latest COVID-19 update on Thursday, April 14<sup>th</sup>, 2022, another Norton 2 resident tested positive for the virus. Residents out of the building for medical reasons unrelated to COVID-19 were removed from our statistics; the RPA total number of residents is therefore ninety-one.
