Since Sunday, April 3<sup>rd</sup>, 2022, thirty-eight out of our 167 active employees tested positive for the virus, equalling twenty-three percent of our workforce and 190 shifts to fill. As of today, thirty-seven of these employees returned to work, equalling ninety-seven percent and 185 shifts restored. We therefore have one active employee out of 167 out sick with COVID-19, equalling 0.5 percent of our workforce and five shifts to replace. Please see the updated general guidelines below.

Visitors must physically distance</li> <li>Visitors are <i>not</i> authorized in common areas unless they are helping during mealtimes</li> </ul>		
CHSLD visitors	Registration at Door Number One is <i>mandatory</i>	
Pets	Permitted	
Visits to a resident on self-isolation or on a unit under outbreak	Permitted; each resident must identify a maximum of four primary caregivers and only one may visit per day, although they may visit multiple times in a day. These individuals must be trained on proper personal protective equipment use.

<b>RPA meals in the Main Dining Room</b>	Permitted with the following directives: <ul style="list-style-type: none"> <li>Please avoid large groups in the elevator and when entering the Main Dining Room</li> <li>Masks can be removed when eating and drinking</li> <li>There must be a maximum of ten people per table</li> <li>There must be one metre between tables</li> </ul>

Library, Cinema Room, and Billiards Room	Permitted
